This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You.

We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

Interpretation and Definitions Interpretation

Definitions

For the purposes of this Privacy Policy:

Account means a unique account created for You to access our Service or parts of our Service.

Cookies are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.

Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.

Personal Data is any information that relates to an identified or identifiable individual.

Service refers to the Website.

Service Provider means any natural or legal person who processes the data on behalf of the Company. Time Frame: The period for which the analysis applies.

Prediction: Expected market movement based on the analysis.

Entry Price: The suggested price at which to enter a trade.

Stop Loss: A recommended price level to limit potential losses.

These signals are intended for informational purposes only and should not be considered financial advice. Users are encouraged to use this information as part of their independent trading strategies

Phone Number:

Email Address:

We ensure that this data is collected, processed, and stored securely in compliance with applicable data protection laws. By providing your phone number and email address, you consent to their use for these purposes as outlined in this policy.
